**-- SECTION 07 - HEALTH HAZARD DATA --**

EYE CONTACT: ..... May cause conditions from irritation to burns. Severe irritation may occur if not irrigated immediately (within seconds of contact). Elevated temperatures increase chemical hazard as well as introduce a thermal hazard in all areas of contact.  
SKIN CONTACT: ..... Prolonged contact of dilute solutions may cause chemical irritation of the skin. It may not produce an an immediate sensation.  
INHALATION:..... Aspiration of fumes and mists of heated solutions cause symptoms of irritation to burns of respiratory system.  
INGESTION: ..... May cause corrosion of mucosal surfaces.  
EFFECTS OF OVEREXPOSURE: ..... Individuals with preexisting diseases of the lungs may have increased susceptibility to the toxicity of excessive exposures to fumes. Severe overexposure by contact may result in irritation or chemical burns. None of the ingredients contained in this product are considered carcinogens.

**-- SECTION 08 - FIRST AID --**

EYES: ..... Flush with water for a minimum of 15 minutes (industry safety standard for all materials). Seek medical attention if irritation persists.

VENTILATION:..... External exhaust preferred. Local exhaust is sufficient if exposure limits are not exceeded. If misting is anticipated, provide suitable ventilation to maintain levels below established exposure limits.  
RESPIRATORY PROTECTION: ..... None normally required; NIOSH approved respirator for mist conditions.  
PROTECTIVE CLOTHING:..... Chemical resistant gloves when mixing or handling. Protective gear sufficient to prevent personal contact. should be worn.  
EYE PROTECTION:..... Tight fitting or chemical workers goggles.

HANDLING AND STORAGE: Do not breathe vapors or mist. Do not allow contact with eyes, or leave in contact with skin for prolonged periods. Wash contaminated clothing prior to re-use.
