-- SECTION 07 - HEALTH HAZARD DATA --

EYE CONTACT:..... May cause temporary, mild eye irritation.
SKIN CONTACT: Product is not expected to cause any skin irritation upon single or repeated contact. Prolonged contact may result in dry skin irritation.
INHALATION:..... Inhalation of oil mists poses a risk of pulmonary disease such as chronic lung inflammation. Shortness of breath and cough are most common symptoms. Aspiration may lead to chemical pneumonitis, which is characterized by pulmonary edema and hemorrhage and may be fatal. Signs of lung involvement include increased heart and respiration rate, and a bluish discoloration of the skin. Gastrointestinal discomfort may develop, followed by vomiting, further increasing the risk of aspiration.
INGESTION: May act as a laxative, resulting in abdominal cramps and diarrhea. No other adverse health effects from accidental ingestion of small amounts of this product are known.
